「依書名瀏覽」功能

本資料庫除原有的「依類別瀏覽」功能外，新推出「依書名瀏覽」目錄，您可從目錄中依次瀏覽【套書名稱】—【分佈年號】—【統計書名】—【統計年代】，最後點選特定年代瀏覽該書全部統計表格。此種方式係以書名及年代為分類基礎，方便您概覽本資料庫所收錄之書籍及單本統計書內之所有表格，若欲了解不同書籍內相似主題的表格，可再利用「依類別瀏覽」目錄瀏覽依特定主題歸類之表格，並搭配後分類功能下各種項目的限縮來尋找您所需的資料。

「圖文合併輸出」功能

本資料庫原於「我的選擇」區中提供詮釋資料的螢幕輸出及 txt 檔下載功能，新的輸出功能調整為「輸出詮釋資料」及新增的「圖文合併輸出」兩大類。

「輸出詮釋資料」中，您可由八個詮釋資料欄位中任意勾選，再選擇輸出於螢幕或下載為 txt 檔，所輸出的資料僅包含詮釋資料之文字。在「圖文合併輸出」功能下，您則可由收入至「我的選擇」區中的表格勾選所需資料，按下「圖文合併輸出」鈕後，螢幕上將顯示該表格的所有彩色 jpeg 圖片，每張圖並附有引用資料，於圖片上方註明圖檔編號、表格名稱、及統計年代，圖片下方則註明出處，包含：書名、出版單位、出版年代、統計名稱、頁次、網址。此功能可協助您同時取得表格內容及引用資料，方便您寫作及再次查詢之用。

「後分類」及「檢索歷程」功能

本資料庫將原有的後分類及檢索歷程功能加以調整，說明如下：

1. 後分類功能之使用：

後分類功能位於檢索結果頁右方「檢索結果分類」區，提供「統計主題」、「統計年代」、「檔案出處」、「統計名稱」、「出版單位」等五種後分類。首先，在您使用檢索、瀏覽功能獲得一定筆數資料之後，可點選以上五種後分類，了解檢索結果的分佈狀況。其次，以年代為例，您可在所分佈的各年代中任選勾選所需年份，點選「排除」或「限縮」鍵調整查詢

資料的範圍。第三，您的限縮結果會呈現在「檢索歷程」區中，因此在完成年代限縮後，還可再選擇其它後分類項目進行排除或限縮，以達到最符合需求的結果。

2. 檢索歷程功能之使用：

您所執行過的檢索詞彙及後分類條件，皆會呈現在檢索結果頁右上方的「檢索歷程」區，在此區中，除了紀錄檢索過程，還可使用以「x」標示的「移除條件」功能及以「[✓]」標示的「遮蔽-On/Off」功能來調整查詢結果。

其中「移除條件」功能是將該筆檢索條件完全刪除，中央的檢索結果頁會呈現依其餘條件所獲得的資料。「遮蔽」功能則是暫時移除該條件，若您認為其餘條件所得之資料不甚相符，可再開啟該項條件，方便您彈性調整檢索方向。當顯示為[✓]時表示該項條件影響檢索結果，顯示為空白[]時即表示該項條件被暫時排除。

以上介紹的各項新增功能，皆為提供使用者更方便的檢索、瀏覽、引用本資料庫之資料所設計，歡迎多加利用！如有任何使用上之不便或建議，歡迎您隨時來信指教，謝謝！

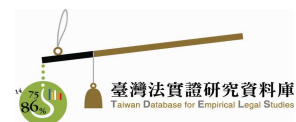
