〈紐約大國民:珍雅各〉紀錄片放映暨映後座談

## ★ 活動緣起:

近來迫遷案往往引起很大之爭議,一昧地追求經濟發展及繁榮都市,卻忽略掉完善的都市規劃 與人民的居住權。當呈現出一個全新的都市面貌的同時,是否代表有人犧牲了?《紐約大國民: 珍雅各》這部紀錄片,係美國在 1960 年代,紐約市預定進行都市計畫並拆除人文聚落的歷史。 片中主角珍雅各當時是一名記者,紐約的都市計畫引起她的關注,進而組織了民眾反對並發起 一連串的行動抵制都市更新計畫。在過往那個女性參政還不興盛的時代,她的行動提醒了人們, 在人口增加及追求現代化的過程中,仍應重視城市的多元樣貌,並時時刻刻記得市民才是都市 主體。她後來也成為《偉大城市的誕生與衰亡》一書的作者,這本書至今仍被都市研究者奉為 圭臬。

「人人皆有天賦之生存權。此種權利應受法律保障。任何人之生命不得無理剝奪。」~《公 民與政治權利國際公約》第6條第1項

2018 年 10 月,兩公約的權威解釋機關一聯合國的「人權事務委員會」(Human Rights Committee),在暌違近 30 年後,終於再次針對公民與政治權利國際公約第 6 條「生命權」規定,提出了第 36 號一般性意見了!

但,「第36號一般性意見」是啥咪碗糕?

按照兩公約施行法的規定,兩公約具國內法律效力,且一般性意見也是適用兩公約時所應參照之解釋。因此,這號最新的 36 號一般性意見的重要性,不言可喻。而新出爐的 36 號一般性意見,洋洋灑灑羅列 70 點,更充分地闡釋生命權,其中牽涉議題也很廣泛,從死刑、女性墮胎權、臨終病患自主權、大規模無差別殺傷害,到失蹤等生命權議題。

其中,就死刑部分:什麼是「情節最重大之罪行」?對於精神障礙者能不能判處死刑?一個死刑判決要經過如何的法律程序才不違反公約的規定?

36 號一般性意見對於這些議題有什麼新的看法呢?

- + This is the call for proposals for the seventh biennial conference on Applied Legal Storytelling. We are offering two deadlines for submitting proposals: January 21, 2019 (priority deadline) and March 11, 2019 (extended deadline).
- → About the Conference

The Applied Legal Storytelling Conference brings together academics, judges, and practitioners. The conference has previously convened in 2007 (London), 2009 (Portland), 2011 (Denver), 2013 (London), Seattle (2015), and Washington D.C. (2017). We are very excited to bring it back to the Mountain West (Boulder) in July 2019.

Applied Legal Storytelling (AppLS) examines the use of stories—and of storytelling or narrative elements—in law practice, legal education, and the law.

This definition is intentionally broad in order to allow people creativity in the way they think and present on the topic. Such topics may include: the ways in which fiction-writing techniques or narrative theory can inform legal storytelling; stories in the law, or law as stories; legal storytelling and metaphor; client story advocacy; legal storytelling and cognitive science; and ethical considerations in legal storytelling.

In an effort to continue the storytelling conversation for this seventh conference, and to welcome new attendees, we are providing resources for those interested in submitting a proposal and who wish to generate ideas or respond to others'. #### Presentation Formats

The conference will include 60-minute and 30-minute time slots. For the 60-minute time slots, we welcome interactive, panel or roundtable presentation proposals, as well as other format types. For the 30-minute time slots, we envision presenters adopting something like the 14–18 minute ted-style format of rehearsed presentations that center on one idea conveyed through narrative, with reserved time for audience questions. On the proposal form, please indicate either a preference for a particular format or your willingness that we accept your proposal in any of the formats and time constraints.

#### → Deadlines

To allow greater flexibility for those interested in submitting a proposal, the Program Committee has established two submission deadlines:

- The Priority Deadline for submissions is January 21, 2019. The Program Committee will review all proposals received by this date by the third week of February.
- The Committee will also consider proposals submitted by the Extended Deadline, March 11, 2019, and will review these proposals by the first week of April.

#### → Proposal format

Please use the format provided at the end of this proposal. We ask for a short summary of fewer than 60 words for use in the conference app, as well as a narrative description of your proposal for selection purposes (500 words, maximum).

## Selection process

The Program Committee will review the proposals and respond according to the submission date. Those who submitted proposals by the Priority Deadline (Jan. 21) will be notified by the end of February if their proposal has been accepted. Those who submitted their proposal by the Extended Deadline (Mar. 11), will be notified by mid-April.

# → Conference Structure and Registration

The conference will take place from July 9 to July 11, 2019, at the University of Colorado School of Law in Boulder, Colorado. Like previous AppLS conferences, this conference will be collegial, inclusive, and supportive of your work.

The 2019 conference will begin with registration and a reception early in the evening of July 9 at the law school. The next two days, July 10 and 11 will be devoted to a plenary session and presentations given in concurrent sessions. The conference will close with a dinner at the end of the day on July 11. The dinner is part of the conference itself— designed to be a signature event that facilitates ongoing conversations.

### ★ About the conference:

Accompanying the spread of constitutional government around the world has been a profound interest in the comparative aspects of constitutional law. Scholars have catalogued the differing features of national constitutions and examined how different constitutional systems resolve common legal issues. So, too, judges faced with legal questions have sought guidance in the decisions of constitutional courts of other nations. While comparative constitutional law is therefore a well-established field, less attention has been paid so far to the comparative dimensions of constitutional history. This international conference series aims to address that shortcoming by energizing the study and analysis of constitutional history from comparative perspectives. It provides a forum for presentation and discussion of current research on issues of constitutional history that crosses national boundaries. It also bring together scholars who, at present, are working on constitutional

histories of single jurisdictions—with the expectation that conversations among these scholars will allow for sharing of methodologies and point also to fresh areas of research that may transcend national boundaries.

For 2019, the focus of the conference is on Uses of History in Constitutional Adjudication. We therefore welcome papers that shed light on the myriad ways in which courts around the world make use of—or ignore—history as they go about deciding cases and the implications and effects of such efforts. In some nations, the historical meaning of a constitutional provision plays an important role in how courts interpret that provision and then resolve questions of constitutional law.

#### → Deadline:

Scholars interested in presenting a paper at the conference should first e-mail a title and summary of the proposed paper along with a CV to Professor Jason Mazzone at mazzonej@illinois.edu . There is no word limit for the proposals but proposals in the range of 500-1,000 words are typical. Proposals received by December 15, 2018 will receive priority. After that date, submitted proposals will be considered if space remains.
